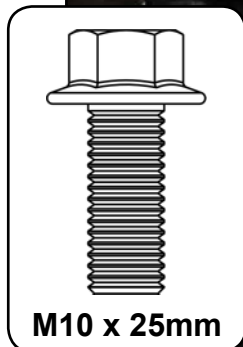
- Install Bracket (B) with hardware shown.



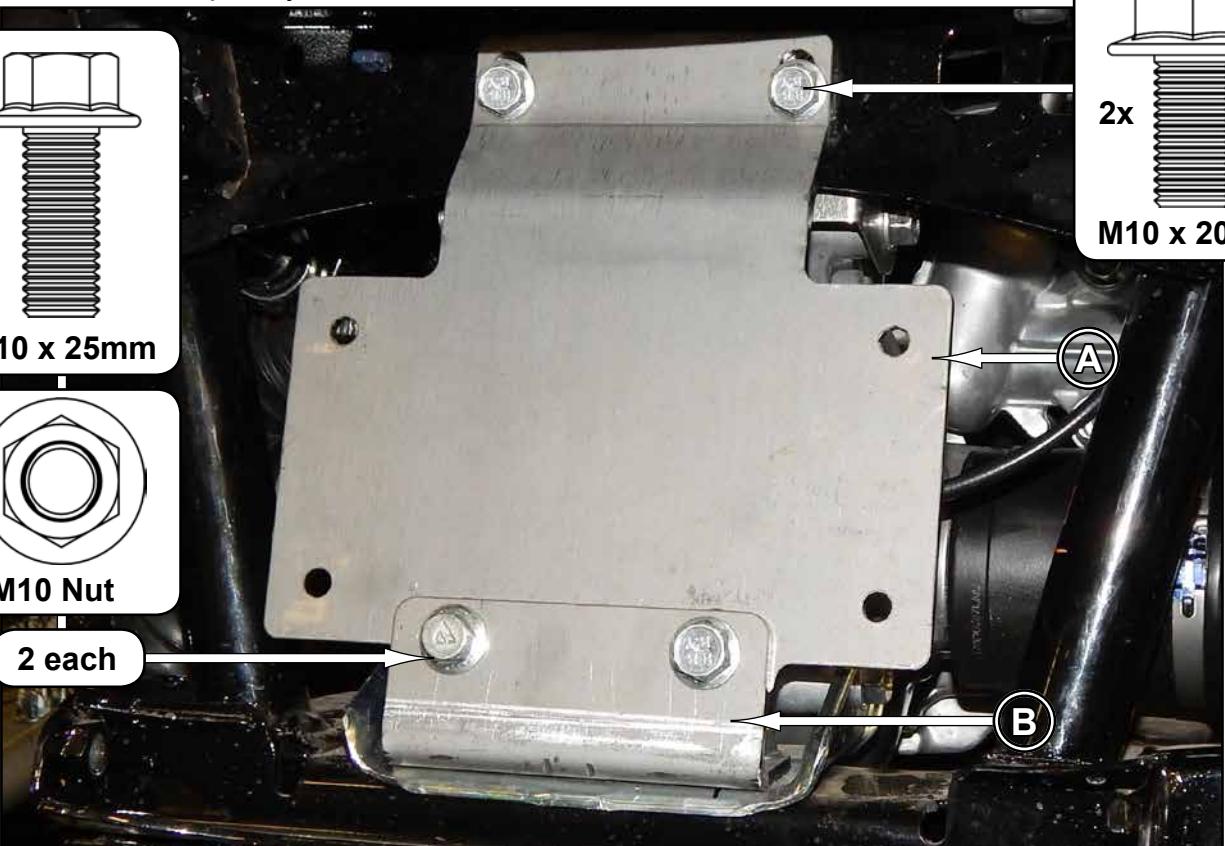
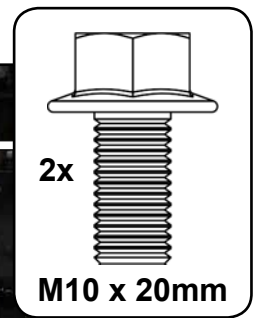
- Place Mount Plate (A) against Bracket (B).

- Secure Bracket (B) to Mount Plate (A) with hardware shown.
- Tighten hardware completely.



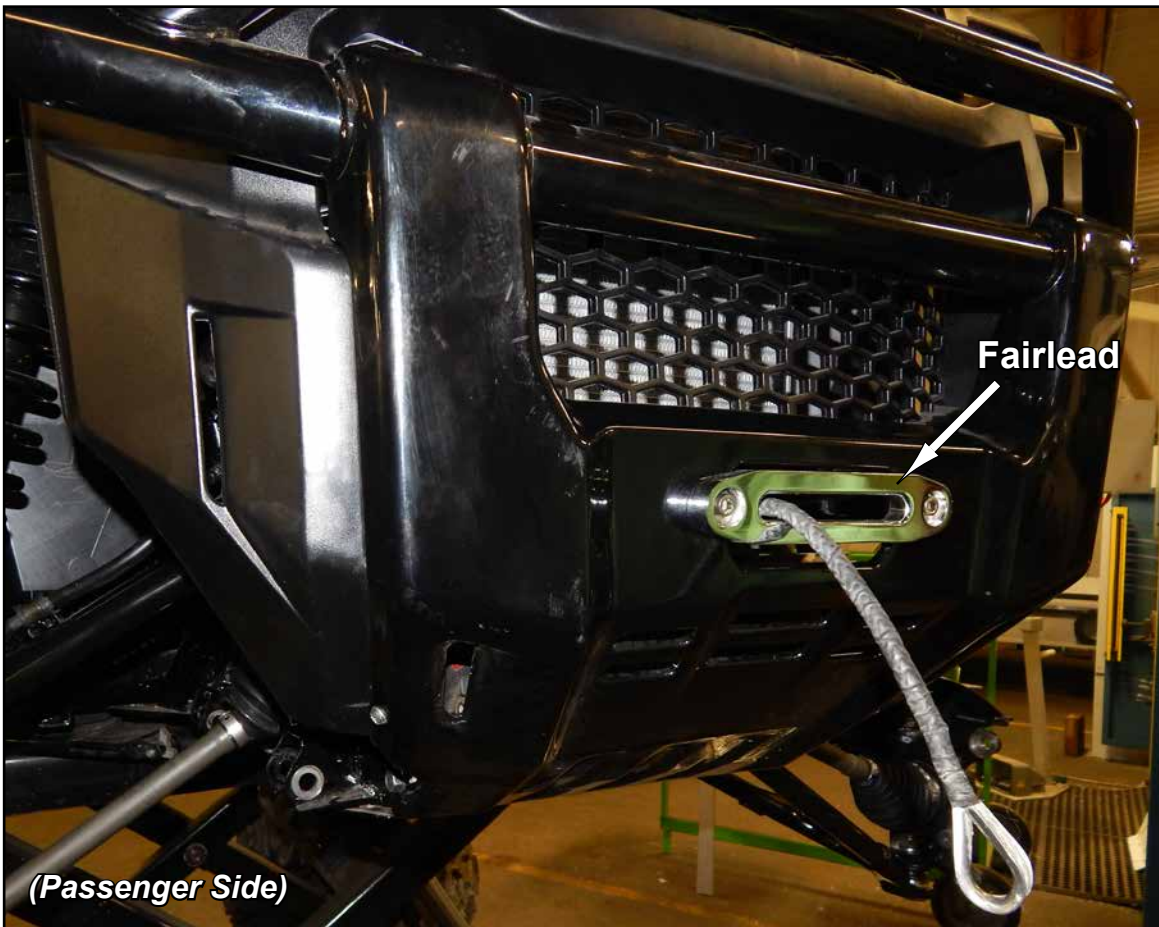

- Install Fairlead to Bumper; Fairlead and hardware included with Winch.
- Reinstall Bumper to machine with stock hardware.
